This includes conditions granted during the public hearing process or by an administrator, if applicable.
 - a. Major subdivision (3 -10 lots) \$300.00
 - b. Major subdivision (11+ lots) \$550.00
- 3. The staff will review the application for "sufficiency" pursuant to Section 19-2.2.6, Determination of Sufficiency. The staff will contact the applicant to correct any deficiencies which must be corrected prior to granting approval.
- 4. Final Plat format and content requirements for Major Subdivisions are reflected in the Administrative Manual at Appendix 'F'.
